# Application Form

This application form is for the Seaside & Country Homes scheme.

Applications for the scheme can only be accepted where the lead applicant is aged 60 or above. Where other members of the household are under 60 years of age they must be either the partner, joint tenant or registered carer of the lead applicant. Where another member of the household is a registered carer they must supply evidence of this with the application.

We are unable to consider applications where there are more than two persons on the application as our properties are only suitable for one or two persons.

The lead applicant must be living in social housing in London and this application must be authorised by the lead applicant's landlord. The landlord will need to check that the lead applicant is not in rent arrears and has no record of anti-social behaviour.

If the application is not authorised by the landlord it will be returned.

This form is to be completed using the Seaside & Country Homes 'Property Notes' booklet and the Seaside & Country Homes 'Guidance Notes for Applicants' booklet.

The Property Notes booklet lists all of the areas where Seaside & Country Homes properties are located. If you only choose areas not listed in the Property Notes booklet then your application will be returned.

The Guidance Notes for Applicants booklet explains how the Seaside & Country Scheme works.
